

MyClickRewards Sweepstakes OFFICIAL RULES

Important: Please read these Official Rules before entering this Sweepstakes (the “Sweepstakes”). By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

Sweepstakes void where prohibited by law. Subject to applicable federal, state, and local laws.

- 1. Eligibility:** The Sweepstakes is open only to individuals who are (a) legal residents of the 50 United States or the District of Columbia (b) at least age 18 (or the age of majority in their state of residence, whichever is older) at the time of entry. Directors, officers, members, managers, and employees of My Click Rewards (“**Sponsor**”), and any of their respective parent companies, affiliate companies, subsidiaries, agents, professional advisors, advertising, promotional, public relations, and fulfillment agencies, consultants, legal counsel, website providers, web masters, and immediate family members (spouses, parent, child, sibling, grandparent, and “step” child, wherever they may live) of each are not eligible to win any prize. - 2. Sweepstakes Period:** There will be a daily Sweepstakes. All Sweepstakes will commence on January 1, 2019 at 12:00:01 pm ET and end on December 31, 2019 at 11:59:59 pm ET.

All entries must be received during the Sweepstakes periods and meet other requirements in these Official Rules to be eligible to win a prize. Sponsor’s or its designee’s computer is the official time-keeping device for the Sweepstakes.

- 3. How to Enter:** To enter, register for this Sweepstakes during the Sweepstakes periods as described below. (There is no charge from Sponsor to register for the Sweepstakes.) To register for the Sweepstakes, visit www.MyClickRewards.com and follow the directions to complete and submit the Sweepstakes registration form, including a valid email address. By registering for the Sweepstakes, you will sign up to receive a daily email and occasional special offers via email from Sponsor. The daily email will include a link that needs to be clicked in order to be entered into the daily Sweepstakes. To opt-out of your email subscription at any time, visit <https://www.myclickrewards.com/unsubscribe/>. and follow the directions to unsubscribe.

Limit: ONE ENTRY PER PERSON PER 24 HOUR PERIOD UNLESS OTHERWISE DISCLOSED. Any attempt to obtain additional entries, including through multiple or duplicate accounts will result in disqualification.

- 4. Identity of Entrant:** All entries must be submitted by the individual entrant. Bulk or automated entries will be disqualified (including entries made using any script, macro, bot, or promotional service). Multiple participants are not permitted to share the same email or social media account. Any attempt to obtain additional entries through fraud or other illegitimate means will result in disqualification, at Sponsor’s sole discretion.

In the event of a dispute about the identity of the entrant, entries will be declared made by the authorized account holder of the email address associated with the account used provided for entry. An “**authorized account holder**” means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the

submitted e-mail address. A potential winner may be required to provide Sponsor with proof that a potential winner is the authorized account holder of the account associated with the winning entry.

- 5. Selection and Notification of Winner:** At the end of each Sweepstakes period, Sponsor will select the name of one prize winner in a random drawing from among all eligible participants at Sponsor's headquarters as listed in Section 15 below. The odds of winning depend on the number of eligible entries received.

The potential winner will be notified via email and/or phone 72 hours after the Sweepstakes period. Except where prohibited by law, Sponsor may require the potential winner to sign and return, within seven days of being notified, an Affidavit of Eligibility and Liability/Publicity Release in order to claim his/her prize. If (i) the attempted notification is returned as undeliverable without a forwarding address; (ii) any required documents are not returned within seven days, including but not limited to the Affidavit of Eligibility and Liability/Publicity Release; or (iii) if winner is otherwise unable to accept the prize as stated, the prize will be forfeited and may be awarded to an alternate winner. Winner may also be asked to provide a photo of themselves and write a short statement about winning the prize for Sponsor to use for advertising, marketing, and promotional purposes. Winner is not required to provide the photo or short statement to receive the prize, nor are they required to complete the survey to redeem a prize. A potential winner must claim the prize within 7 business days of notification or the potential winner will forfeit the prize.
